

Colorado Springs Utilities Freedom to Pay Your Way Grill Giveaway
OFFICIAL RULES.

THIS PROMOTION

- Promotion Period:** The Colorado Springs Utilities ("CSU") Freedom to Pay Your Way Grill Giveaway (the "Promotion") begins at 12:00:01 a.m. Mountain Time ("MT") on June 25, 2018 and ends at 11:59:59 p.m. MT on July 9, 2018 (the "Promotion Period"). CSU's computer is the official time-keeping device for the Promotion.
- Promotion Scope:** CSU will randomly select one (1) winning Participant (as defined below) and the winning Participant will receive one (1) Prize, as stated below. The drawing will occur between July 10 and July 13, 2018. The drawing will include eligible Participants who newly enroll in AutoPay, Budget Billing, eBilling, and/or Pick My Payment Date between June 25, 2018 and July 9, 2018.
- Eligibility:** This Promotion is open only to legal residents of the United States (excluding Puerto Rico, Guam and the U.S. Virgin Islands), who are 18 years or older at the time of entry, are a Colorado Springs Utilities customer, who enroll in CSU's AutoPay, Budget Billing, eBilling, or Pick My Payment Date services during the Promotion Period, and who maintain enrollment, at a minimum, through the Promotion Period (collectively "Participant(s)"). Customers will be entered once for each of the listed programs they enroll in. Employees of CSU (permanent or temporary), their immediate families (spouse, parents, children and siblings and their respective spouses) and individuals living in the same households of such employees are ineligible to participate. Existing customers whom are enrolled in AutoPay, Budget Billing, eBilling, or Pick My Payment Date prior to the Promotion Period are not eligible for this Promotion. Void where prohibited by law and subject to all federal, state and local laws.
- How To Enter The Promotion:** A Participant is entered into the Promotion by enrolling in CSU's AutoPay, Budget Billing, eBilling, and/or Pick My Payment Date program during the Promotion Period and remaining enrolled in the program through the Promotion Period. You can enter the promotion through CSU's MyAccount portal and enrolling in AutoPay, Budget Billing, or eBilling on www.csu.org. To enroll in Pick My Payment Date, customers must speak with a customer service representative by calling 719-448-4800. CSU customers with more than one account may enroll more than one eligible account in AutoPay, Budget Billing, eBilling, or Pick My Payment Date during the Promotion Period. All entries must be completed and received by July 9, 2018, by 11:59:59 p.m. to be eligible to win. If applicable, normal internet access and usage charges imposed by Participants' online service provider will apply.
- Determination of the Winner:** The winning Participant will be chosen at random. Contestants will be entered once for each program they are enrolled in from the following group: AutoPay, Budget Billing, eBilling, and/or Pick My Payment Date. After selecting the winning entry, CSU will contact the winning Participant using the email address or phone number listed on the winning Participant's customer account. If unable to contact the winning Participant by these methods, certified letter will be sent to the mailing address on file in his/her Utility Account information. Entries are declared made by the authorized CSU account holder at the time of entry submission. A Participant claiming a potentially winning entry may be required to provide CSU with proof the Participant is the authorized CSU account holder for the address associated with the potentially

winning entry. The odds of winning the Promotion depend on the number of Participants who enter.

6. **Prizes and Approximate Retail Values ("ARV"):** A total of one (1) "Char-Broil Performance Black and Stainless Steel 4-Burner Liquid Propane Gas Grill with 1 Side Burner" (the "Prize") will be awarded, to the one (1) winning Participant who has validly subscribed and continue to subscribe in one of CSU's AutoPay, Budget Billing, eBilling, or Pick My Payment Date service during the Promotion Period as stated in these Official Rules. The Approximate Retail Value for the Prize is \$199 (U.S. Dollars). No warranty, and/or guarantee is provided with the Prize(s). Taxes, as applicable, related to all prizes including income taxes are the responsibility of the individual winners. The winning Participant will be solely responsible for assembly and transportation of the Prize. CSU and the winning Participant agree that CSU is not responsible for the use and function of the Prize and will not be responsible for any damages caused by and/or associated with the Prize. In the event of any issues with the Prize, the winning Participant should contact the Prize manufacturer directly.

The Prize will be forfeited if a winning Participant is in non-compliance with these Official Rules, cannot be contacted, provides incorrect email or mailing addresses, is ineligible, and/or fails to claim the Prize within 5 calendar days after being notified of selection as the winning Participant. In the event of such forfeiture, CSU will choose a new winning entry from the pool of validly submitted entries received by July 9, 2018 by 11:59:59 p.m., through an additional random drawing performed in the same manner as the other drawing. CSU reserves the right at its sole discretion to disqualify any individual who tampers or attempts to tamper with the entry process or the operation of the Promotion; violates the Official Rules; or acts in an unsportsmanlike or disruptive manner, or with intent to abuse, threaten or harass any other person. Any attempt by any person to deliberately undermine the legitimate operation of the Promotion may be a violation of criminal and civil law, and, should such

an attempt be made, CSU reserves the right to seek damages from any such person to the fullest extent permitted by law. CSU's failure to enforce any term of these Official Rules shall not constitute a waiver of provision. The Promotion shall be subject to the laws of the State of Colorado without reference to conflicts of laws and the Colorado Springs City Charter. Nothing in these Official Rules shall be interpreted to limit or prevent the protections afforded to CSU under the Colorado Governmental Immunity Act, C.R.S. § 24-10-101, *et seq.*

The Participant agrees to the collection, processing and storage of his/her personal data by CSU for purposes of the Promotion and enrollment in CSU's AutoPay, Budget Billing, eBilling, or Pick My Payment Date.
