**Sales Tax**  
 Sales tax is assessed only for electric and natural gas service on behalf of state and local governments unless tax-exempt status is filed and on record with us.

**Discontinuance of Service Due to Nonpayment**  
 In cases where services have been discontinued for nonpayment, the customer shall be charged the per day access and facilities charge for the entire period, including those days the service is discontinued.

**Third Party Notification**
