How the business custom water rebate works

1. Read all eligibility requirement, terms and conditions, rules, and instructions.
2. Download, complete and submit the custom water rebate preapproval request form prior to purchasing your new equipment.
3. Mail your complete application to:

4. A conservation specialist will set up a time to inspect/verify equipment slated for replacement.
5. Following the visit to your facility, we'll notify you of qualification and rebate amount in writing.
6. Allow eight weeks for rebate processing. *
