This project involves a comprehensive analysis of existing public recreational access within the North Slope Recreation Area (NSRA). It will evaluate current trail systems and access points, providing recommendations to enhance recreational opportunities while maintaining alignment with infrastructure protection, public safety, and long-term sustainability goals. The project will explore and develop alternatives for improved public access that minimize adverse impacts on existing utility operations, critical infrastructure, drinking water sources, natural resources, and the overall recreational experience. 

#### **Existing Conditions Overview**





#### Areas of Focus - Crystal












#### **Areas of Focus - Catamounts**
